Mosquito Dunks float and release a long-term biological control agent for up to 30 days at the water's surface, which settles and is eaten by mosquito larvae.

DIRECTIONS FOR USE

Summit Mosquito Dunks Biological Mosquito Control are for use only when mosquito larvae are present in:

- standing water wholly confined to the property of the user where there is no existing outflow beyond the property limits that remains for more than a week and cannot be drained (for example, flooded depressions, ponds).
- containerized water (for example, bird baths, flower planters, discarded tires, ornamental ponds, and rain barrels) that cannot be emptied, drained, flushed or changed at least weekly.

DO NOT apply this product to any water that is designed to flow beyond your property limits (for example, ditches, drains, rain gutters or catch basin sumps that flow into weeping tile beds or municipal storm drain systems).

BEFORE APPLYING THIS PRODUCT to a water body where there is a possibility of outflow beyond your property limits, contact your provincial/territorial regulatory authority as a permit may be required.

To help prevent mosquito infestations on your property, get rid of mosquito breeding sites. Do this by emptying, flushing or draining containerized and standing water, whenever practical, at least weekly or more frequently if mosquito larvae are present. For example, remove leaf litter from rain gutters, drill holes in bottoms of tire swings or discarded tires, empty water collected on pool covers, turn over wheelbarrows and other containers, empty trapped water from recycling bins or trash containers, cover rain barrels with fly screen netting, replace water in bird baths and chlorinate swimming pools. **Mosquito Dunks** are a ready-to-use product and NOT to be used in spray mixtures. DO NOT apply by any type of irrigation system.

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that

is inconsistent with the directions on the label. The user assumes the risk to persons or property that arises from any such use of this product.

OUTDOOR USE:

Use one (1) **Mosquito Dunk** for up to 6 sq. metres water surface, regardless of depth. To prevent floating away, they can be anchored with a string or staked in place with a small stick.

Mosquito Dunks can be used whole or in pieces. Allow a minimum of 48 hours for control. If necessary, reapply at 30 day intervals if mosquito larvae are detected. Use this table to determine how much to apply:

Surface Area of Standing Water Use:	
0.1 to 3.0 sq. metres	¼ DUNK
3.0 to 6.0 sq. metres	½ DUNK
Over 6.0 sq. metres	1 DUNK

per 6.0 sq. metres

FIRST AID

If on skin or clothing:	Rinse skin immediately with plenty of water. Remove contaminated clothing and wash separately before reuse. If irritation occurs and persists or is severe, seek medical attention.
If in eyes:	Hold eye open and rinse slowly and gently with water. Remove contact lenses, if present, then continue rinsing eye. If irritation occurs and persists or is severe, seek medical attention.
If inhaled:	Move to fresh air, apply respiration if needed and seek medical attention.
If swallowed:	Rinse mouth and throat with copious amounts of water. DO NOT induce vomiting. Promptly contact a physician or poison control centre. DO NOT give anything by mouth to an unconscious person.
General:	Seek medical attention if irritation or signs of toxicity occur and persist or is severe. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

PRECAUTIONS AND PERSONAL PROTECTIVE EQUIPMENT

KEEP OUT OF REACH OF CHILDREN. MAY CAUSE SENSITIZATION, CAUTION EYE IRRITANT. Avoid contact with skin, eyes, or clothing. Avoid breathing dust/spray mist. Wear a long-sleeved shirt, long pants, waterproof gloves, shoes and socks as well as eye goggles when handling or applying the product and during all clean-up activities. DO NOT apply directly to treated, finished drinking water reservoirs or drinking water receptacles when the water is intended for human consumption.

STORAGE: Store **Mosquito Dunks** in the original closed container in a cool (25°C or less), dry place and use them within one year from date of manufacture to ensure microbial purity and potency.

DISPOSAL: Make the container unsuitable for further use. Wrap and dispose of container with household trash.
