## Tree pest caterpillar control program continues

**Winnipeg, MB** – Today, June 12, 2018 weather permitting, the City of Winnipeg's Insect Control Branch will continue its tree pest caterpillar control program. Yesterday evening, the Insect Control Branch completed treatment in Insect Management Areas 33 and 39.

Starting at 9:30 p.m. today, June 12, 2018, crews will continue treatment in Insect Management Areas 4 (Munroe West, Rossmere B) and 32 (Earl Grey, Ebby Wentworth, Grant Park, McMillan, Rockwood, Roslyn) and begin treatment in Insect Management Area 10 (Central St. Boniface, Dufresne, Holden, Mission Industrial, North St. Boniface, Tissot). The program will be targeting the forest tent caterpillar, elm spanworm, and the spring and fall cankerworm species. Spraying will not occur if there is significant rainfall or winds are greater than 20 km/hr.

Treatment will be conducted utilizing *Bacillus thuringiensis* subspecies *kurstak*i (Btk), a biological, organic product which is sprayed from high pressure tree sprayers directly onto the foliage of the trees located in City parks and on City boulevards. Once Btk is ingested by the tree pest caterpillars, they stop feeding and perish approximately two to three days later. This product has been approved for use in Canada by Health Canada's Pest Management Regulatory Agency, and will be used in accordance with federally approved label directions by licensed pesticide applicators.

## **Buffer zones**

All buffer zones will be respected. Crews will ensure that the sprayer is not treating within 30 metres on each side of a registered property on the front street, side street, and rear lane.

Residents can apply for a 30-metre buffer zone in order to exempt their property during a tree pest caterpillar treatment program. Property owners not wanting insecticides applied on or adjacent to their principal residence may register as "Anti-Pesticide Registrants" for tree pest caterpillar control using Btk. Those who wish to register must provide identification that ties the registrant to the address being registered for a buffer zone. A photocopy or scanned document like a driver's licence, Manitoba Hydro, BellMTS or other utility bill will suffice as acceptable identification proving primary residence.

There are three different options to register:

- Contacting 311
- In person at 1539 Waverley Street.

A 72-hour turnaround time is required for processing.

## Register for notification

Citizens may register for email notification regarding adult mosquito and/or tree pest caterpillar control programs by visiting <a href="City of Winnipeg - Insect Control Register for Notification">City of Winnipeg - Insect Control Register for Notification</a>. They can also register for telephone notification by contacting 311 and leaving their name, address and phone number. Once registered, residents will receive automated phone or email notification identifying the area(s) of the City in which the Insect Control crews are intending to work, weather permitting.
