

Public Service Announcement Wednesday, July 31, 2019

Adult nuisance mosquito fogging program will not occur tonight

Winnipeg, MB – The City of Winnipeg's Insect Control Branch will not fog tonight, July 31, 2019, due to low mosquito activity. The city wide average adult mosquito trap count for today was 27. All quadrants are substantially below 100.

When adult mosquito activity is depressed, fogging is not an effective method of control as the droplets of DeltaGard® 20EW must be in the air when the mosquitoes are flying in order to hit and kill the mosquitoes.

Daily public service announcements

Public Service Announcements (PSAs) will be released daily at least eight hours in advance of fogging. These PSAs will identify the Insect Management Areas the Insect Control Branch is planning to treat that evening, weather permitting. Until further notice, fogging will be carried out on a daily basis between the hours of 9:30 p.m. and 6:30 a.m. Fogging will not occur when temperatures are below 13 degrees Celsius and/or wind speeds are not conducive to fogging.

The insecticide DeltaGard® 20EW will be used. This insecticide has been approved for use in Canada by Health Canada's Pest Management Regulatory Agency. DeltaGard® 20EW will be used in accordance with federally approved label directions by licensed pesticide applicators.

Register for notification

The Insect Control Branch offers an automated telephone and email notification system. Residents who register for this service will receive daily phone or email notifications for adult mosquito control activities. To register for the automated email or telephone notification system, residents can go to City of Winnipeg – Register for Notification or contact 311.

Buffer zones

All buffer zones will be respected. Crews will ensure that the sprayer is not treating within 90 metres on each side of a registered property on the front street, side street, and rear lane.

Property owners not wanting insecticides applied on or adjacent to their principal residence may register as "Anti-Pesticide Registrants" (APR) for the adult nuisance mosquito control program. Those who wish to register must provide identification that ties the registrant to the address being registered for a buffer zone. A photocopy or scanned document such as a driver's licence or a utility bill will suffice as acceptable identification proving primary residence. Remember – a 72-hour turnaround time is required.

Do your part

Property owners are also encouraged to eliminate standing water on their properties by taking one of the following steps:

- Dump It! containers
- Drain It! eavestroughing or unused containers
- Cover It! rain water collection containers
- Fill It! low-lying areas
- Treat It! biological larvicide
