



Adult nuisance mosquito control program continues tonight

Yesterday evening, we were unable to fog for adult nuisance mosquitoes due to high winds. We will continue spraying at 9:30 p.m., weather permitting, in the following insect management areas:

- IMA 11 (Glenwood, Norwood East, Norwood West)
- IMA 12 (Archwood, Maginot, Niakwa Park, Stock Yards, Windsor Park)
- IMA 13 (Alpine Place, Elm Park, Lavalee, St. George, Varennes, Worthington)
- IMA 15 (Niakwa Place, Southdale, Southland Park, Symington Yards, The Mint)
- IMA 16 (Fraipont, Island Lakes, Royalwood, Sage Creek)
- IMA 17 (Dakota Crossing, Meadowood)
- IMA 19 (St. Vital Perimeter South)
- IMA 20 (La Barriere, Parc La Salle, Perrault, Richmond Lakes, St. Norbert, Trappistes, Turnbull Drive)
- IMA 22 (Fairfield Park, Richmond West, Waverley West, Waverley Heights, Bridgwater Centre, Bridgwater Forest, Bridgwater Lakes, Bridgwater Trails, Prairie Pointe, South Pointe)
- IMA 26 (Betsworth, Ridgewood South, River West Park, Roblin Park, Southboine, Westdale)
- IMA 27 (Elmhurst, Eric Coy, Marlton, Ridgedale, Varsity View, Vialoux)
- IMA 29 (Edgeland, Old Tuxedo, South Tuxedo, Tuxedo)
- IMA 30 (Central River Heights, J.B. Mitchell, Mathers, Sir John Franklin, South River Heights)
- IMA 31 (Crescentwood, North River Heights, Wellington Crescent)

Adult mosquito control occurs between 9:30 p.m. and 6:30 a.m. and will not happen with heavy winds or when temperatures are below 13 C.

We will apply DeltaGard® 20EW according to federally approved label directions using licensed applicators. This insecticide has been approved for use in Canada by Health Canada's Pest Management Regulatory Agency.

Buffer zones

Buffer zones make it so we can't apply DeltaGard within 90 metres of a specific property.

You can apply for a buffer zone adjacent to your principal residence. Applications must include a letter and photo ID linking you to the address in question. They can be submitted:

We require a minimum 72-hour turnaround time.

Do your part

We also encourage you to stop mosquitoes from multiplying on private properties. You can eliminate standing water by following our [#draindumpcover](#) protocol:

- Drain water from eavestroughing or unused containers
- Dump standing water from containers like wheelbarrows, bird baths, and kiddy pools when they aren't in use
- Cover rainwater collection containers and undrainables like larger pools and water tables

You can also fill low-lying areas where water pools and treat your properties with commercially available pesticides.
