Regarding: City of Winnipeg Downtown Bike Lane System and Street Improvements: Donald Street Reconstruction – Portage Avenue to Notre Dame Avenue, Bid Opportunity No. 531-2017

Further to the previous notice the above-noted pavement reconstruction project is expected to re-start approximately May 7, 2018, weather dependant. The project was divided into two stages. Stage 1 was constructed in 2017 and included construction of the two east lanes of Donald Street from Notre Dame Avenue to Portage Avenue. Stage 2 includes construction of the two west lanes and construction of a new sidewalk within the same limits. The remainder of the project is expected to take approximately 6 weeks to complete.

During Construction a minimum of one lane of traffic southbound shall be maintained at all times. There will be limited sidewalk access due to safety concerns and no loading zones or on-street parking will be allowed.

Access to private approaches and parking lots will be maintained to the extent possible. Any interruptions to access will be reviewed with the applicable property owner prior to the disruption. The work will include the removal of the existing roadway pavement and sidewalks, construction of new concrete roadway pavement, installation of new catchbasins, construction of new sidewalk complete with paving stones and other streetscaping enhancements, as well as new street lighting.
